Scope of application

1.1 Freight rates include

Rail transport seaport – inland terminal and v.v.

Handling from wagon to chassis and v.v. at the inland terminal

Provision on a standard chassis

Provision at the first loading / unloading spot in the inland including acceptance / return of the empty container at the inland terminal / depot.

Waiting times at the loading/unloading point(s) including 2 hours free. Waiting times in connection with a multi/customs stop are free including 0.5 hours. The waiting times at the loading/unloading points and the waiting times in connection with a multi/customs stop are considered separately and charged separately if necessary. Waiting times at railroad stations / depots will be invoiced in the event of incorrect data, incorrect registrations or missing containers in accordance with the regulations for multi/customs stops.

If our vehicle arrives before the agreed date and the customer starts loading/unloading before the agreed date, the waiting time is counted from the start of loading/unloading.

1.6 Container storage / self delivery at port Rotterdam

Our tariffs do not include terminal handlings in case of a self-delivery / self- pick up.

For containers that are delivered to or collected from the terminals below in Rotterdam by the customer, we charge the handling costs incurred in accordance with our display.

When processing via the following terminal, any storage fees incurred in the event of network disruptions or termin failures will be charged as follows. Please also refer to our newsletter.

1.7 Disposal over empty containers

We point out that the container depot commissioned by the shipowner is responsible for orderly delivery of empty equipment. This applies to the type of container, as well as its condition including its state of cleaning. Possible charges incurred due to erroneous delivery or refusal on the part of the consignor are not covered by IGS Intermodal. Costs of an unsuccessful trip will be invoiced accordingly.

1.8 General and miscellaneous information concerning handling

Scheduled shipping dates which are advised by us are only valid on the same-day, longest until 6 P.M.

In case of later order commissioning, the loading possibilities advised can no longer be guaranteed.

Loading / unloading slots at the seaports are calculated **across days**. Possible shifts of loading and unloading are possible. IGS Intermodal cannot be held liable for any costs (detention / demurrage) incurred by this.

Checking container availabilities, releases or customs documents is not a service included in the freight rate. General availability and provision of existing releases of full and empty containers are assumed.

Unsuccessful trips or waiting times due to non-availability of container(s), lack of releases, registrations or others are invoiced separately, excluding a processing fee of **€ 70,00**.

In case of transporting dangerous goods, the client is obligated to provide all necessary information and to observe all national and international regulations.

We generally reject liability for damaged tarpaulins when transporting open-top containers.



When handing over the loading unit, the customer assumes liability that the loading units and the goods loaded therein are suitable for intermodal transport and safe for transport and operations, without this being dependent on negligence.

Customs charges are generally at the expense of the goods.

“Verpflichtungsscheine” / obligation notes are to be deposited at the acceptance terminal by the customer.

1.9 Administrative / service flat rate

For additional and extraordinary handling in the area of invoicing above and beyond our regular effort, we reserve the right to charge a service flat rate in the amount of **€ 50,00**.

IGS Intermodal reserves the right to charge a cancellation fee of **205.00€ per TEU** if a planned export loading cannot take place. This applies in particular in the following cases:

- Missing release at the empty container terminal



- Customs-related uncertainties or missing accompanying documents
- Incomplete or incorrect order data
- Delays or problems at the loading location (e.g., no loading readiness, no contact person on site, inaccessible loading area)
- Untimely delivery of the container to the shipping terminal according to the scheduled loading date

1.11 Side loaders

Please observe the following conditions when delivering or picking up containers by sideloader:

- The ground conditions on-site must be suitable and stable for the operation of heavy-duty trucks to ensure safe lifting and setting down of containers.
- Access routes must be freely accessible and not restricted by structural or local conditions.

If positioning is not possible or only possible with restrictions due to unsuitable conditions on-site, any resulting detour costs, delays, or damages shall be borne by the customer.

1.12 Demurrage and detention

Costs for container rental as well as for container storage (demurrage and detention) are generally not borne by us.

In exceptional cases, cost coverage may be reviewed within the framework of the ADSp, provided that demonstrable fault on our part exists.

1.13 Dangerous goods

Dangerous goods classes excluded from transport:

- Class 1: Explosives (e.g. fireworks – only upon request)
- Class 4.1: Flammable solids with temperature control (UN 3231 to UN 3240)
- Class 5.2: Organic peroxides with temperature control (UN 3111 to UN 3120)
- Class 7: Radioactive materials (only after approval by our Dangerous Goods Officer)
- Class 8: Sulphur trioxide (UN 1829) with a purity of 99.95% when transported without inhibitor in tank containers
- Additionally excluded are all substances listed in Table 1.10.3.1.2 of the RID/ADR regulations 2025 (current version).

Further restrictions and prohibitions can be found in the respective hinterland conditions of the involved terminals.

General Notes:

- Dangerous goods transports are generally accepted subject to technical and operational feasibility on rail and road.
- The transport of dangerous goods in limited quantities (LQ) is permitted in combined transport, provided that all requirements under ADR (road), RID (rail), and IMDG-Code (sea transport) are met. If a total quantity of more than 8 tons per vehicle is transported, vehicle marking is required. In this case, the same costs as for regular dangerous goods transport apply.

1.14 Disposition of dangerous goods at the terminal

Intermediate storage of dangerous goods due to operational requirements is possible for a maximum of 24 hours at the terminals.



1.15 Refusal of containers due to congestion of inland terminals

IGS Intermodal cannot be held liable for any costs resulting from the announcement of short-term acceptance stops at inland terminals.

1.17 Transport of waste subject to approval

Prior to commissioning the order, we require the “Abfallschlüsselnummer (ASN)” / Waste Key Number to check if a transport can be carried out. Usually, only waste included in the green list which is intended for recycling or laboratory inspections (according to EU transport regulations) may be transported.

Feasibility of the transport will be checked on the part of our railway operator and trucking contractor according to the AVV number. Please refer to our terminal conditions for details on surcharges.

1.18 Transports of excessive height and weight

Open-top containers as well as flat racks can exclusively be transported “in gauge”.

Excessive heights and excessive widths are excluded. By handing over an open-top container or a flat rack, the customer agrees to assume liability that these and the goods loaded within are suitable for intermodal traffic and safe for transport and operations and especially adhere to ISO dimensions, without this being dependent on negligence.

1.19 Product groups excluded from transport

Groups of goods that are excluded from transportation

Ethyl alcohol, liqueurs and other spirits, raw tobacco, cigarettes, ammunition/weapons, removal goods, live animals and plants, meat and meat products, cereals and all other products covered by the cereals market regulation (Regulation (EEC) No. 1766/92), motor vehicles

1.20 Goods with prohibitions and restrictions

Despite the free movement of goods and globalized trade, restrictions must be observed when importing and exporting certain goods in order to provide special protection for vulnerable areas.

These special regulations, which result from both national and European law, can restrict the import, export and transit of goods (so-called bans and restrictions)

1.21 T1 transit procedure / Fiscal an import customs clearance

As a rule, the transit accompanying documents (OCD) are valid for 6 calendar days, counted from the day the respective container is issued. In exceptional cases, it is possible to issue a connecting T1.

All resulting costs, including any presentation to the responsible customs office, will be charged according to the display.

The customer must ensure that the transit accompanying documents (OCD) are reported and/or forwarded to the competent customs office of destination upon receipt. Furthermore, the recipient / customer shall check the transit accompanying documents (OCD) for expiry and correctness before removing the seal. If the data transmitted for the creation of the transit accompanying documents is incorrect, we will clarify the discrepancies with the responsible main customs office in consultation with our customer.



For this service, we charge a one-off fee of € 170.00 per process//VBD. Any additional costs incurred, such as reminder fees, warning fines and costs resulting from tax assessments, are not covered by this flat rate. Customs duties incurred due to non-completion of shipping documents are due for payment immediately.

The value of goods per T1 is limited to € 250,000.00.

T1 or NCTS shipments with a value of goods exceeding € 250,000.00 are still possible, but must be agreed in advance with IGS Intermodal Container Logistics Nederland B.V

1.23 Additional side charges

IGS Intermodal reserves the right to impose surcharges and/or additional ancillary fees due to developments in diesel or energy prices and as a result of handling bottlenecks at seaport and hinterland terminals.

IGS Intermodal also reserves the right to immediately introduce corresponding surcharges due to new laws or measures at state or federal level.

IGS Intermodal reserves the option to make adjustments or revoke validity during the year.

A corresponding insurance policy has been signed by us.

Note:

The liability of the freight forwarder is in any case limited to 10,000 SDR per damage event or series of damage events with one and the same cause of damage. Taking into account the aforementioned maximum amount, the liability damage, depreciation or loss of the contractual goods is limited to 4 SDR per kilogram of the damaged or devalued goods or the lost gross weight.
